

**NOTICE OF ELECTION**

**SCHOOL BOND ELECTION  
PLATTE COUNTY SCHOOL DISTRICT 0005  
(LAKEVIEW COMMUNITY SCHOOLS)  
IN THE STATE OF NEBRASKA**

**TUESDAY, OCTOBER 15, 2019**

“Shall Platte County School District 0005 (Lakeview Community Schools) in the State of Nebraska issue its bonds in a total principal amount not to exceed Twelve Million Dollars (\$12,000,000) for the purposes of financing the costs of (1) constructing additions to the District’s existing junior/senior high school building for classrooms, offices and a competition gymnasium and related facilities, (2) renovating and improving portions of, the District’s existing junior/senior high school building, and (3) acquiring and installing necessary furniture, equipment, apparatus and site improvements for such additions and building; said bonds to be issued from time to time, to be sold at such prices, to bear interest at such rates, to become due at such times, and to have such other terms and provisions, all as may be fixed and determined by the Board of Education of the District; and

“Shall the District cause to be levied and collected annually a special levy of taxes against all the taxable property in the District sufficient in rate and amount to pay the principal of, the premium, if any, and the interest on said bonds as the same become due?”

- FOR** **said bonds and tax**
- AGAINST** **said bonds and tax**

Qualified electors voting in favor of said proposition shall blacken the oval opposite the words “FOR said bonds and tax” following said proposition, and qualified electors voting against said proposition shall blacken the oval opposite the words “AGAINST said bonds and tax” following said proposition.

The polls will be open continuously from 8 A.M. to 8 P.M. on said date.
